**MOU BETWEEN INDIAN NAVY AND AXIS BANK LTD.**

Dear Sir,

1. The Indian Navy and Union Bank of India had signed a Memorandum of Understanding (MOU) on 30 Jul 08 to provide various banking facilities to Naval personnel who operate their salary account from your Bank.

2. Post implementation of VI<sup>th</sup> CPC report, the Govt. has also revised the pension of pre-2006 and Post-2006 retirees vide letter 17(4)/2009/1/D (Pen/Pol) dated 11 Nov 08 and 17(4)/2008(2)/D(Pen/Pol) dated 12 Nov 08 respectively. In the recent past, few cases have come to light where the pension of these retired Naval personnel/family pensioner have been revised incorrectly and arrears have not been paid on due dates. It has also been brought to the notice of this Headquarters that in some cases, the revision of pension/arrears have not been effected/paid till date. It is pertinent to mention that pension of pre-2006 retirees is to be revised as derived after consolidation as per **para 4** or under the provisions of modified parity as per **para 5** of letter dated 11 Nov 08, (as amended) whichever is beneficial to the individual. In view of the above, it is requested that concerned official's be directed to look into the grievances of retired Naval personnel and resolve them amicably to the satisfaction of pensioner/family pensioner. You are further requested to contact the following authorities at New Delhi and Mumbai, in case of any difficulties/doubts or clarifications on the admissibility of pension/family pension of Naval pensioners banking with you.
