Subject :- **ANOMALY IN FIXATION OF PAY ON PROMOTION FROM THE RANK OF LT COL / EQUIVALENT TO COL (TS) / EQUIVALENT POST AVSC RECOMMENDATIONS.**

Sir,

I am directed to refer to SAI/SNI/SAFI 2/S/98 and convey the sanction of President in regard to anomaly in fixation of Pay on promotion from the rank of Lt Col/Equivalent to Col(TS)/Equivalent which occurred post AVSC recommendations implementation with effect from 16 Dec 2004 . In this connection, Govt. has agreed to remove the anomaly in respect of officers of the rank of Col (TS)/ equivalent who were promoted between 16 Dec 2004 to 31 Dec 2005, and were drawing one or more stagnation increment(s). However, post VI CPC, the Col (TS)/Equivalent rank of officers pay scales would continue to be regulated by SAI/SNI/SAFI 3/S/2008 and its subsequent corrigenda.

2. The revised pay is to be regulated in the following manner for Lt Col/ Equivalent in the following four possible scenarios from the period 16 Dec 2004 to 31 Dec 2005: -

(i)	Pay drawn as Lt Col /Equivalents (say)	Rs. 17100/-	Rank Pay - Rs. 1600/-
(ii)	Stagnation Increments drawn as Lt Col / Equivalent (Nil)	Nil	
(iii)	Pre revised pay in the Scale of Col (TS) (Rs. 17350/-)	Rs. 17350/-

(i)	Pay drawn as Lt Col /Equivalents (say)	Rs. 17100/-	Rank Pay - Rs. 1600/-
(ii)	Stagnation Increments drawn as Lt Col / Equivalent (One)	Rs. 400/-	
(iii)	Pre revised pay in the Scale of Col (TS) (Rs. 17350/- + 450/-)	Rs. 17800/-

(i)	Pay drawn as Lt Col /Equivalents (say)	Rs. 17100/-	Rank Pay - Rs. 1600/-
(ii)	Stagnation Increments drawn as Lt Col / Equivalent (Two)	Rs. 800/-	
(iii)	Pre revised pay in the Scale of Col (TS) (Rs. 17350/- + 450/- + 450/-)	Rs. 18250/-	

**Illustration 4:-**

(ii)	Stagnation Increments drawn as Lt Col / Equivalent (Three)	Rs. 1200/-
